Invitation for Electronic Bids

1. **Provincial Assembly Secretariat, Janakpur, Dhanusha** invites electronic bids from Nepalese eligible bidders for the construction of **following projects** under National Competitive Bidding procedures.
2. Eligible Bidders may obtain further information and inspect the Bidding Documents at **Provincial Assembly Secretariat, Janakpur, Dhanusha** or may visit PPMO website www.bolpatra.gov.np/egp.
3. Bidder may download the bidding documents from PPMO's Web Site www.bolpatra.gov.np/egp, up to 2078/01/03. Bidders should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 4. Pre-bid meeting shall be held at **Provincial Assembly Secretariat, Janakpur, Dhanusha** at **1 P.M. on 2077/12/25**.
5. Electronic bids must be submitted to **Provincial Assembly Secretariat, Janakpur, Dhanusha** through PPMO website www.bolpatra.gov.np/egp on or before **12 noon 2078/01/05**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **1 P.M. on 2078/01/05** at **Provincial Assembly Secretariat, Janakpur, Dhanusha**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format, which shall be valid for 30 days beyond the validity period of the bid. Bid security amount can be deposited at Dharauti account no.1220100202030000 on behalf of Pradesh Lekha Niyantrak Karyalaya, Province no.2, Janakpur-8, Rastriya Banijya Bank or an unconditional bank guarantee from Commercial Bank or Financial Institution eligible to issue Bank Guarantee as per prevailing Law .
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
